

\$10,000 HOME MAKEOVER SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility Requirements: The \$10,000 Home Makeover Sweepstakes (“Promotion”) is open to legal residents of the United States residing in Oakland, Macomb or Wayne counties of Michigan. Entrants must be 18 years of age or older and must be able to provide documentation proving that they own their home. This home must be in a suitable condition (as determined by Kopke or its designees) for installation of the prize (including compliance with local building codes and regulations). Employees of Kopke Remodeling & Design (“Sponsor”), its parent, subsidiary and affiliated companies, distributors, franchises, and advertising/promotion agencies involved in the administration of this Promotion (“Promotion Parties”) and the immediate family members (spouse, parent, child, sibling, grandparent and spouse or “step” of each) and those living in the same household of each such employee are not eligible. To enter on our blog: visit www.kopkehome.com/blog and search keyword “sweepstakes”. You will see our Rafflecopter widget where you can earn multiple entries for subscribing to our newsletter, liking us on facebook, giving us your contact info, etc.

To enter at a Home Show: Visit our booth at one of the many Home Improvement Expos we are participating in this year. For a full list, check our blog.

All fields of the entry form must be filled out correctly and legibly. The address listed on each entry form must be the address where the prize is to be installed if such entry is selected as a winner. By entering the Kopke Home Makeover Sweepstakes, the contestant hereby consents to receiving promotional updates via mail, email or telephone.

Winner Selection and Notification: Winner will be selected in a computerized random drawing from all eligible entries received during the Promotion Period. The odds of winning are determined by the number of entries received prior to the time of the prize drawing. There will be only one winner, announced in January 2016. Winner will be announced via facebook and email, and notified by email and phone.

Redemption: Prize cannot be redeemed for Cash. \$10,000 value refers to retail value, as determined by Kopke, based on its then-current price list. The prize is non-transferable. The prize must be installed at the address listed on the winning entry form. Installation must be provided by Kopke's personnel or designee. Prize money can be used towards any combination of any of the following projects: Kitchen, Bathroom, Addition, Sunroom, Basement, Siding, Roofing, Windows, Interior or Exterior Doors, Gutters, Insulation. Not valid on Handyman Services. \$10,000 must be used toward a single contract during the calendar year 2017. Any remaining dollar amount not used by January 1, 2018 will be erased and not refunded. If the project chosen exceeds \$10,000 in value, the homeowner must make up the difference using cash, credit, or financing options which are also available.
